Addressing Social Drivers of Maternal and Infant Health in Maternity Care Settings

Operational Guidance

Raising the Bar for Maternal Health Equity and Excellence recommends that maternity services integrate screening at intake for social, mental health, and physical health needs and periodic rescreening across this episode; include identified needs in care plans co-created with childbearing women and people; and implement well-designed processes to support meeting these needs.¹

A broad range of unmet social needs – from experiencing intimate partner violence or homelessness to having a substance use disorder – adversely affect maternal and infant health outcomes.² Addressing social needs is an important pathway to achieving better maternity outcomes. And the duration of this episode of care and frequency of visits make it an opportune time to implement this intervention. Although this work in progress is not well established within maternity care, screening in this population has identified high rates of social needs and strong support for attention to social needs in pregnancy.³

This operational guidance provides core resources to enable maternity services to identify appropriate screening tools, incorporate them into systems and workflows, and identify and support the use of needed services. Explore the *Raising the Bar toolbox* for companion resources on delivery system and payment reforms that support addressing social needs within maternity care.⁴

Technical Support for Documenting and Sharing Social Needs and Follow-Up Actions

Medical coding systems and electronic health records increasingly support documentation of both social needs and processes for addressing identified needs. Innovative Program to Watch: Abundant Birth Project

Providing direct unconditional cash payments has been a successful way to enable childbearing families in historically marginalized communities to flexibly identify and meet priority and often changing needs and experience better birth outcomes. This can be a mechanism for rapid, inclusive, and equitable impact in the context of economic and health challenges. Expecting Justice created the Abundant Birth Project to pilot this trust-based concept among childbearing families in California. An evaluation of its impact on preterm birth and other important outcomes is under way.
